TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE No. 121014

An ordinance levying taxes for all town purposes for Algonquin Township Road District, McHenry County, Illinois, for the tax year 2014 collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Algonquin Township Road District, McHenry County, Illinois, as follows:

SECTION 1: That the sum of Four Million Forty-Eight Thousand Eight Hundred Thirty-Five Dollars and No/100 (\$4,048,930.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge Fund
Social Security Fund
Illinois Municipal Retirement Fund
Insurance Fund
Audit Fund
Equipment and Building Fund

for the year 2014.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


