TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 1512091

An ordinance levying taxes for all town purposes for Algonquin Township, McHenry County, Illinois, for the tax year 2015, collectable in 2016.

BE IT ORDAINED by the Board of Trustees of Algonquin Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of One Million Eight Hundred Thousand Three Hundred Eighty Dollars and No/100 (\$1,800,380.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Town Fund

General Assistance Fund

for the year 2015.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


CERTIFICATION OF TAX LEVY ORDINANCE

TOWN LEVY**


