TAX LEVY ORDINANCE

ORDINANCE NO. 2018-1216-A

An ordinance levying taxes for all road purposes for Algonquin Township Road District, McHenry County, Illinois for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Algonquin Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of Three Million Six Hundred Sixty Two Thousand Four Hundred Fifteen Dollars and Zero Cents (\$3,662,415.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

- Road & Bridge Fund
- Social Security Fund
- Illinois Municipality Retirement Fund
- Insurance Fund
- Audit Fund
- Equipment and Building Fund

for the year 2018.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

Notice and hearing requirements of Section 18-60 through 18-85 or the Truth in Taxation law are not applicable.


The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and hearing were not necessary.
