**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 2018 1218-B**

An ordinance levying taxes for all town purposes for Algonquin Township, McHenry County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Algonquin Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of One Million Five Hundred Sixty Four Thousand Nine Hundred and Ninety Four Dollars and No/100 (\$1,564,994.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Town Fund

General Assistance Fund

for the year 2018.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
